Your Excellency Dr. Diarra, Dr. Frazer, Esteemed Ambassadors, Distinguished Guests, Ladies and Gentlemen:

I take great pleasure in welcoming all of you to Dubai and the United Arab Emirates. I am especially pleased to infer that you all must share a common interest in investing and undertaking business in Africa. I and many other UAE citizens share that interest as well. This conference will strengthen our common interest.

Led by the extraordinary visionary Dr. Diarra, the staff at the Africa Legal Network has arranged a challenging program that confronts vital issues of importance. An incredibly strong faculty of sixty-five talented and experienced experts will speak over the next two days. - And how to develop and support the networks of business leaders needed to strengthen business and economic relations between Africa and the Gulf?

The value of your Conference lies in the attention you give to all these important issues and in your ability to develop a common understanding of various challenges and opportunities.

Thank you all for your dedication to progress and development in Africa—the world's second largest continent with the world's second largest continental population. In this conference, I am reminded of a Nigerian proverb that declares this: "In the moment of crisis, the wise build bridges and the foolish build dams." You may not feel a threat of crisis today and tomorrow, but I hope that you heed the proverb nevertheless. Dams will not help us bridge the gulf. Best wishes for successful and wise bridge-building.
